Pilot Qualification:	All pilots must hold a valid licence and FAI license and shall be of sufficient standard to meet the demands of an international competition.
Technical req.:	Each competing glider shall be of sufficient performance and standard of airworthiness to meet the demands of international championships. It must be based on a Paraglider certification or a prototype certification from one of the CIVL recognised test organisations. A prototype certificate requires a load test and a declaration of line specifications signed by the manufacturer and the testing body. The organisers have the right to refuse any glider not of acceptable standard or configuration.

Insurance: Documentary proof in English or German of insurance covering public liability risk to a value of 1.5 Mio. Euro must be presented to the Organisers before the start of the Championships, as well as a personal accident insurance Covering medical assistance and reparation. Helicopter Rescue insurance is obligatory.

Liability: All pilots fly on their own responsibility. All pilots accept without restriction to hold the Organisers, its bodies and members harmless and waive all claims to compensation. – See page 4; DHV- Liability disclaimer.

I declare the following with regard to participation in competitions organised by the DHV in 2007. This declaration in no way limits the responsibilities of the competition organisers.

1. The Risks

I the undersigned, am informed of, and fully understand the risks involved in competition flying: e.g. factors leading to a crash either during training sessions or the actual competition. I agree that success in flying competitions is often connected with increased risks, in particular that I may have to push myself to my own physical limits. I know and appreciate that partaking in flying competitions can set my health or even my life at risk.

These risks are present for all competition participants or trainees, particularly due to environmental and atmospheric factors, technical equipment and natural or man-made obstructions. I agree that not all sequences of events are predictable or controllable, and therefore may not be avoidable or averted through preventative safety measures.

2. Risk taking

I must judge for myself if the competition or training task under the current circumstances lies within my capabilities. I will inform the jury immediately of any obvious safety issues. By starting, I agree that the site is suitable and useable for competition flying. I am fully responsible for the equipment I use, and route I choose in order to complete the task.

3. Personal Liability

I agree that I may be liable for all damages, bodily or to property, incurred to third parties through my flying activities. I agree that the organisers are in no way obliged to control or check my flying equipment.
